## PLANS UNDERWAY FOR 2010 GA DAIRY CONFERENCE

Dairy producers now have online access to key components of the new National Dairy FARM Program: Farmers Assuring Responsible Management.

Created by NMPF, with support from Dairy Management Inc., the National Dairy FARM Program is a voluntary, nationwide program designed to bring consistency and uniformity to animal care through education, on-farm evaluations and objective third-party verification.

To participate in the National Dairy FARM Program, producers, coops, processors, and state and regional dairy producer organizations can contact NMPF. On-farm evaluations will begin in 2010; third-party verification will follow in 2011.

***NATIONAL MILK ANNOUNCES CHANGES TO CWT PROGRAM***

Last month National Milk announced that a special CWT Subcommittee, appointed as part of the National Milk Producers strategic planning effort, Foundation for the Future, would evaluate new programs that CWT could utilize to achieve its goal of maintaining producer milk prices at a level that will provide positive profit margins.

The CWT Committee approved replacing the Herd Retirement Program with a Whole/Partial Herd Retirement. This will allow producers to send a part of their herd to slaughter as long as they maintain the milk production reduction agreed to for twelve months.

The Bred Heifer program will continue to be an option in the Whole/Partial Herd Retirement Program. CWT will continue to analyze the various benchmarks it uses in determining the optimum time to implement possible future whole/partial herd retirements. # IMMIGRATION REFORM STILL ON HOLD

Another year has passed without comprehensive immigration reform, and immigration remains a challenge for all employers, especially in agriculture. The linchpin of immigration compliance remains proper completion of I-9 forms. The Obama administration has promised more focus on immigration enforcement against employers, and inspections and prosecutions of employers increased in 2009. Of

note, the administration recently called for 2,000 additional employer audits, and the first round of those audits included dairies in the Northeast. While enforcement has not yet focused on California, it could happen and dairies must be prepared. All dairies should review their I-9s and make sure their paperwork is in order for an audit.

The so-called "safe harbor" regulation that would have required employers to fire employees who could not resolve mismatched names and social security numbers has been withdrawn by the Obama administration. Accordingly, dairies should not fire any employee merely because a notice has been received that there is a mismatch. Employers should make sure that they have not made a clerical error leading to the mismatch, and should direct employees to resolve the issue with the Social Security administration. It remains to be seen whether the Obama administration can deliver on its promise of immigration reform, but until something happens, the I-9 remains the most important element of immigration compliance.
